§ 2 . The 16th WFTAO Meeting

BCJ co-held the 16th WFTAO (World Federation of Technical Assessment Organizations) annual meeting, along with CBL (Center for Better Living) from September 19 to 22 at BCJ, in Tokyo. This was the second time for BCJ and CBL to host the WFTAO meeting as Japanese representative-organizations; the first time was in 1999. BCJ and CBL have been WFTAO members since the establishment of the federation in 1996.

The meeting was attended by 10 member organizations from 9 countries including BCJ and CBL.

The participants exchanged information on the current situations and activities of their organizations and related information and opinions. BCJ gave an update report and a report on damage from the March 11th earthquake and

tsunami. We also discussed how to better promote WFTAO, and the possibility of admitting new members.

The next meeting will be held in Czech Republic in September 2012.

On Sep. 21, after the Annual Meeting, BCJ and CBL held an open seminar on “Approaches to Environmental Considerations for Building Products”, in which Dr. Shuzo Murakami, Chief Executive of Building Research Institute gave the keynote speech: “R & D of LCCM (Life-Cycle Carbon-Minus) Housing”, followed by presentations by three overseas WFTAO members and CBL.

- Technical evaluations of building products for compliance with environmental and sustainability requirements in the United States (Mr. Michael Beaton, Senior Vice President of ICC-ES)
- Certification of environmentally-friendly housing components in Japan (Mr. Jun-ichi Murakami, Executive Director of CBL)

The presentations given in this seminar will be uploaded onto the BCJ website by the end of November.


